MINUTES – the minutes from the Board meeting of Dec 20 were previously distributed. Jeff Conklin made the motion *to accept as written*, Misha Duvernoy seconded the motion. All directors approved. Motion carried.

FINANCIALS – The financial statements through Dec 2022 were previously distributed and are accepted/approved.

Show Committee – the show committee is working on a few things and will provide recommendations when ready.

Registrations – Dec 52 Transfers – Dec 94 New members – 27

Rules/Regulations/Grievance Committee -

Grievance received from S. Crook 12/5 is in committee process.

Grievance received from V. Himes 12/14 – Samantha VanSickle recused herself from this discussion due to mutual business dealings with one of the parties. Gale Rempel reviewed the comments from the GVHS lawyer regarding GVHS right to remove Paulette Stoudt from membership and deny renewal of her judge card. The revised conclusions and recommendations from the GVHS grievance committee were reviewed and discussed.

Gale Rempel made a motion to Expel Paulette Stoudt permanently from GVHS membership because there is no doubt that the history of her actions amounts to conduct that has caused lack of confidence in the GVHS so long as she remains a member and carded judge. GVHS bylaws, Section 3, Subsection (b)(4) and Section 3, subsection (b)(5). This will result in her expired GVHS judges card not being renewed, and she will be notified she may not attend any event hosted by the GVHS. Jeff Conklin seconded this motion. All the Directors present and voting, voted yes, none opposed. The GVHS bylaws require 2/3 of the Directors present and voting to remove a member. Motion passed.

The grievance committee recommended that the BOD immediately obtain counsel to seek a restraining order on behalf of the GVHS and its members against Paulette Stoudt so as to mitigate against her appearing at any GVHS hosted event, including but not limited to the upcoming Annual Meeting. After discussion no motion was made regarding this recommendation.

Jeff Conklin made a motion for the GVHS to obtain security to be present at the February, 2023 annual meeting event. Misha Duvernoy seconded the motion. All Directors

present and voting, voted yes. Motion passed. Barb Snyder will get a quote for approval of the expenditure.

Jeff Conklin made a motion that the unused portion of Paulette Stoudt's lifetime membership fees and the fee she paid to attend the meeting in February, 2023 be returned to her. Misha Duvernoy seconded the motion. All Directors present and voting, voted yes, motion approved.

Samantha VanSickle rejoined the BOD meeting.

Licensed Official Committee- reviewing score sheets.

Judge Committee Proposal -

- 1. After discussion, the first line of the first paragraph of the document will be removed.
 - 2. The current regulations lined out in our rulebook regarding Judge interactions with exhibitors is 60 days, versus the recommendations put forth in the judge committee proposal which is 6 months. Section B. #2, #3, #4 6 months will be changed to 60 days.
 - 3. Section B. Item 10 will be removed. Last year the board discussed this issue and decided against similar restrictions.

OLD BUSINESS

2023 AGM – deadline to register to attend 2/1, costs discussed regarding printing up the program booklets, printing the seminar books, free drink tickets, purchasing the note pads and pens for the attendees, and the "spin the wheel" prizes. All approved the expenditures.

Samantha VanSickle suggested a free raffle for a GVHS lifetime membership. The raffle will be held at the end of the awards. If lifetime member wins they can gift the membership to someone else or sell it to an eligible person.

Colombia stallion licensing – The ACOLGVS will be sending signed document, they want to require negative FIS testing and negative PSSM1, or 1 carrier PSSM1 test result.

NEW BUSINESS

Hall of Fame Horses – achieved through evaluations. In the past we had an article in The Vanner featuring the horse and all the offspring that helped achieve the HOF. All Directors agreed to do the same as in the past for an article in The Vanner.

SE Region GHSA – The Gypsy Show Horse Association is seeking approval as a GVHS club/region with the GVHS. There states to represent will be MS, AL, FL, GA, SC, NC, VA, TN. Gale Rempel made a motion to *accept this region/club*, Jeff Conklin seconded the motion. All Directors present voted yes, none opposed, motion approved.

Discounted membership -There is a request made for GVHS to give discount for lifetime membership to Seniors over age 65. After discussion, no motion was made.

Honoring Terri Martel - Denise Shaw has volunteered to work on a way to honor Terri Martel. She has suggested a specific class at a show, or a scholarship. The Directors discussed and approved to pursue to establish the Terri Martel Halter Gelding Championship class at the FHC National show. Barb Snyder will contact Gail Shrine to establish it as an annual class. Denise Shaw will be asked to research an award with a budget of \$300.

Request for seminars in Breeding, Driving and Horsemanship for amateurs & youth – an outline of the seminars has been requested from the person who is proposing the seminars. Samantha VanSickle suggested creating video seminars. It was also discussed having the regions/clubs put on seminars and the GVHS help fund and promote them. This topic is tabled for future discussion.

Resolution without meeting – January 6, 2023, the BOD reviewed the work hours for Barb Snyder and Denise Krause during 2022. The purpose was to determine fair pay based on the type work and hours worked. When Barb Snyder took the Executive Director position, September 2021, it was expected to be a part time job. It has proven to be a full time position due to the growth of the organization. Both are working full time. A motion was made by Gale Rempel to increase Barb Snyder's pay from \$2000.00 per month to \$3000.00 per month beginning January 2023, which is equal to what Denise is being paid. Motion seconded by Misha Duvernoy. All in favor ...Jeff Conklin, Kate Walls, Gale Rempel, Misha Duvernoy, and Samantha VanSickle. None apposed. Wages will be reviewed again at end of the year for 2024.

OLD BUSINESS

2023 AGM – final plans being made, 80 attendees for the seminar.

Colombia stallion licensing – final document not yet received from ACOLGVS

Fees & expenses to be paid to seminar trainees was previously discussed. Expenditure(s) approved.

Duane Stutzman, since he is already going to the meeting, we will be responsible to pay him \$250 per day = \$500 total plus free registration for the event.

Jill Paxton, since she will be there for a different conference the same time, we will be responsible to pay her \$250 per day = \$500 plus free registration for the event.

Julie Usoff, she will be reimbursed for flight, and hotel (friday, saturday, sunday) plus the \$250 per day = \$500 plus free registration for the event.

Seminars – Providing seminars for membership was discussed. It was agreed that this is something regional clubs should provide, and potentially the GVHS could help. Example was the club organize and provide venue, the GVHS could assist with funding to pay the professional presenter, and promote the event through social media and newsletter. This program will be presented to clubs for further development.

NEW BUSINESS

Request for change to December 2022 minutes - A GVHS member volunteered post election to serve as Secretary or Treasurer. Approved.

Youth Committee – Gale Rempel made a motion to create a Youth Committee, Kate Walls seconded the motion. All agreed, none opposed.

Advisory Council – council procedures discussed. Purpose is a task force to collect information and advise the Board of Directors. Members will be chosen from different regions and may include members, judges, other professionals. Important to have a good cross section of 10 council members. Council members will rotate. Full details will be presented at the annual meeting.

Jeff Conklin made a motion to create the Advisory Council, Kate Walls seconded the motion. All approved, none opposed.

Hall of Fame – Person – the discussion is to revise the Achievement Program already in place and rename it Hall of Fame – Person. The persons already honored under the previous Achievement Program will remain in the Hall of Fame – Person.

Misha Duvernoy made the motion to change the name of the program and those already honored under the old program would be in the Hall of Fame - Person. Jeff Conklin seconded. All approved, none opposed.

A nomination committee will be formed to review nominations for entry into the Hall of Fame, and that committee will also review nominees for elections. Samantha VanSickle made the motion to create the nomination committee. Gale Rempel seconded. All approved, none opposed.

Changes to Code of Ethics- Current language shown, new language highlighted.

Members of the Board of Directors, Officers and Committee Chairman will conduct themselves in an exemplary manner by conducting business affairs of the Society in good faith and with honesty, integrity, due diligence, and reasonable competence such as to favorably reflect on their leadership and the Gypsy Vanner Horse Society. Directors, Officers and Committee Chairman must ensure that their social media content is and remains polite and professional. BOD and Committee members (rightly or wrongly) are subject to heightened scrutiny because of their role within the organization and they should strive to be professional and inclusive at all times, and should avoid creating or perpetuating content that could cause others to question their ability to treat all members fairly.

Where the code refers to Rules/Bylaws/Grievance committee change it to Grievance committee.

A Director who voluntarily resigns their position as a GVHS Director prior to completion of their term will be ineligible to be nominated to serve as a Director for a minimum of six years from the date of their termination or resignation. The exceptions are, if a Director resigns due to personal medical reasons, with a majority vote

from the remaining Directors, that person may be nominated to run for election without the waiting period. Should a Director be removed for cause after review by the Rules Bylaws & Grievance Committee, and a majority vote by the Board of Directors, or if they resign, they may not run again for a BOD position, for 6 years — but may after a period of three years petition the Board of Directors for review of the original removal which may or may not reinstate their right to run for election.

Gale Rempel made a motion to make these changes to the Code of Ethics, Samantha VanSickle seconded the motion. All approved, none opposed.

REGISTRATION RULE – Proposal to change rule #4 to change the name of a registered Gypsy Vanner.

4. The original Certificate of Registration is returned along with the name change request, applicable fee, and a letter from the original owner/breeder person who originally registered and paid to register the horse, agreeing to the name change.

Samantha VanSickle made the motion to change the rule as shown (delete lined out text and ad highlighted text). Misha Duvernoy seconded the motion. All approved.

Horse name change – Paulette Stoudt submitted a request with backup documents regarding issues of the name change of two horses. After review, it was agreed that Paulette did not get the choice to accept the final name approved by the breeder, which was somewhat different than the requested name. Paulette will be given the choice to leave the names as they are now, change back to the original names, or request a new written approval from the breeder (person who named the horse and paid for the registration).

Officer Elections -Barbara Snyder had volunteered to serve as interim Treasurer upon the death of Terri Martel and was voted in as Secretary/Treasurer for 2023 by the Directors. On February 3, 2023 Barb resigned as GVHS Secretary / Treasurer. Resignation accepted. On February 6, 2023, the candidates interested were considered and a vote taken for Treasurer, Denise Krause 5 votes, Lamar Ingulli 0 votes. A vote for Secretary Denise Shaw 5 votes, Lamar Ingulli 0 votes.

Changes to qualifications for Directors & Officers – Director, President & Vice President nominees must serve on a GVHS committee(s) at least 2 years prior to becoming a nominee. Director and Officer nominees are expected to have been a general or lifetime member in good standing for at least two years prior to submit their name as a candidate. and had active involvement in GVHS programs and events for a minimum of two years. Candidates should shall have at least one to two years serving on a GVHS committee. Candidates with the equivalent amount of time actively participating in and promoting the GVHS in a positive manner at GVHS events, activities, breed demonstrations and GVHS annual meetings, may be considered on a case by case basis". A Director candidate must also own a registered Gypsy Vanner.

GYPSY VANNER HORSE SOCIETY ANNUAL GENERAL MEMBER MEETING **FEBRUARY 24, 2023** At 1:00 PM in Grapevine, Texas, President Gale Rempel called the meeting to order. She welcomed everyone to the meeting and made introductions of the Directors and staff member in attendance. Gale Rempel spoke about strengthening the GVHS for future growth through strong active committees made up of members who want to make a difference. New committees, AGM, Nominations, and Youth; have been created and the Board is looking for volunteers. This will shift the flow of communications more from members to the committees who will then provide information and recommendations to the Board of Directors. A form was distributed so members in

attendance can volunteer for their first choice of committee to serve and their second choice. The announcement of

the committees and volunteer process will be to all membership and once sufficient time is given for initial sign up some will be notified that they are chosen to serve on a committee. Others will be kept on the list for future consideration.

President Rempel announced the creation of an Advisory Council. This group of about 10 people will provide feedback and suggestions addressing the future of the GVHS. This group will rotate annually and be made up of people from all areas served by the GVHS. It may include members, breeders, trainers, show managers, and other professionals. The council will be chaired by the President and members chosen by the President and Board of Directors.

President Rempel then turned the meeting over to Executive Director Barbara Snyder to present the Annual Report for 2023. The GVHS mission and goals were reviewed with an emphasis made that it is about the breed. The next review was to show who the Directors and Officers were for 2022 and who they are for the year 2023. The financial review showed total assets of \$203,488 which is all in cash. The liability total is \$7348 which includes the youth account and deposits. Adding the liabilities to the opening balance, retained earnings and net for 2022 shows balanced accounts totally \$203,488. The income statement was reviewed showing a grow in membership of 13.7%, registrations 7.1% and transfers change of -2.8%. Gross profit total is \$358,780 a 11% increase over 2021. Total expenses of \$344,379 is 4.5% higher than 2021. Net profit is \$14,401. Barb explained that the standard admin costs for non profit organization is 15% - 45%, and the GVHS admin expense is 22.8% of Gross Profit so well within the acceptable range. She also explained that maintaining the asset accounts at this level, and the expenses, plus keeping the net profit low or near break even shows excellent financial management for a non profit organization.

A registry review revealed that at the end of 2022 there are 10,561 registered Gypsy Vanner horses. 55.2% are mares, 27.4% stallions and 17.4% geldings. The stallion / gelding numbers could be skewed because people fail to report the gelding of their stallions. Stud book graph shows the majority of horses are in the regular Gypsy Vanner studbook, around 15% in the pre studbook which is mostly geldings that have not had the DNA testing done. This led to a discussion regarding not requiring geldings to be DNA tested. Some in attendance think the GVHS should require DNA testing on all horses.

At the end of 2022 the GVHS has registered horses in 20 countries. A bar chart was displayed showing the consistent growth of the GVHS over the last 15 years.

The GVHS Evaluation Program was reviewed showing the award levels and introducing the new young stock award levels. Young stock (under age 3) that achieve 75+ score in conformation and movement will be designated First Premium, and those that score 65-74 will be designated as Second Premium. All young stock are expected to be reevaluated when mature. There was discussion regarding the evaluations program and when the Gypsy Vanner can be considered mature. It was made clear that a score on a horse over age 3 is called a permanent score, but a horse can always be re-evaluated anytime. The most current score becomes the actual "permanent" score. A review of the locations where 175 evaluations were done in 2022, plus the current list of the planned 2023 evaluation locations was revealed. A total 919 horses have been evaluated with an average score of 75.2.

There were 36 Gypsy Vanner Pointed shows in 2022 using 64 judges. 476 Gypsy Vanners were shown by 278 owners. 179 amateurs showed 250 horses. 75 youth showed 96 horses. There was a reminder to those in attendance to utilize the judge and show feedback forms. It was suggested by a member that show managers include the feedback forms in the show packet they send out. The points required for the award levels in the Legion Program was reviewed, and it was show that over \$27,000 was invested in member awards in 2022 and over \$14,000 in show sponsorships.

The cost of ads for the 2023 Vanner magazine was displayed. President Rempel stated to those in attendance to make sure everyone who wants an ad to let her know today the size of the ad so the space can be reserved before space runs out.

Many of the achievements that happened in 2022 were reviewed; judges training, evaluator training, educational videos, software development, forms updated, use of QR codes, development of regional clubs, new committees, classes and awards programs added, updated show rules, increased sponsorship to shows, posting show results on the website, adding the "stay informed" page to the website, trainers directory, show managers page and handbook, additional information on the online registry and publishing the PSSM1 and FIS results on the registration certificates.

The stallion licensing process for Colombia and Wayne Hipsley gave detail regarding how it works, what other breeds outside the North America require, and why the Colombia GVHS affiliate wants to do stallion licensing. Some in attendance expressed interest in requiring it in all the GVHS. This also started discussion of a "do not breed" rule where the breeder could designate that a horse is not to be bred and it could be stamped on the registration certificate.

A review of some of the plans for the future revealed; developing more international affiliates, managing the current programs, requiring GVHS show rules be used starting 2024 show season; the judges newsletter, more regional clubs; international events; continued software development; youth stock evaluation program and the new committees.

The Hall of Fame – Person program was introduced. Currently the GVHS had a program called the Platinum Achievement Award which recognized people for their long term service to the GVHS. This program will now be called GVHS Hall of Fame-Person and will offer several categories that service will be recognized. The people who had already been honored in the Platinum Achievement Award program will be in the Hall of Fame. There will be a nomination committee created that will review annual nominations for this honor.

The date and location for the 2024 AGM is February 23-25, 2024 in Orlando, Florida. The newly established AGM committee will plan this event with budget and guidance from the Board of Directors.

The group then commenced with general questions and discussion. Topics were:

Person from each region designated as a member liaison.

A junior horse in the show rules is currently 5 and under, should be age 6 due to slow maturity of the breed.

Suggested that the GVHS points system be changed to reflect number of horses in the ring. The software investment and time requirement to reprogram with GVHS points calculation software will be investigated.

Suggestion of a horse health committee, an international committee and a membership committee.

Request to add the 5 star status to the registration certificate.

Suggestion that horses should have to be in canter/lope classes to achieve Legion Hall of Fame.

Suggestion to offer a discounted membership when transferring a horse.

Regarding the required use of GVHS show rules starting 2024. Supplemental rules cannot override a GVHS rules but can a supplemental rules can be more restrictive?

The Why We Love the GVHS slide should be given to new members and handed out at events.

A question was raised if there is a way to recognize past horses that made an impact but did not have enough show points to be in the Hall of Fame.

Combining youth and amateur in a class if only 1 or 2 in a class. This currently was allowed and is no longer allowed.

There is a request to require a specific number of youth classes to promote youth.

The meeting adjourned while some remained for further discussion and socializing.



Board of Directors Meeting Minutes March 28, 2023

MINUTES – The minutes from Feb 15, 2023 meeting previously distributed. Samantha VanSickle made motion to accept as written, Kate Walls seconded, none opposed.

The minutes from Annual General Meeting previously distributed. Gale Rempel made motion to accept as written, Misha Duvernoy seconded, none opposed.

FINANCIALS – Financial statements through Feb 2023 previously distributed, no issues. Kate Walls made motion to accept, Samantha VanSickle seconded, none opposed.

COMMITTEE REPORTS

Show Committee – the show committee recommended the following rule changes and updates.

- 1. Page 6-13- Falls- to "If an exhibitor loses their hold on the horse's lead then the horse and the exhibitor will be excused from the ring"
- 2. On page 23 we need to add Riders showing in Hunter Attire with Hunter Appointments are allowed to use bits that are included in the Hunter Division. Riders showing in Dressage Attire with Dressage Appointments are not allowed to use bits that are included in the Hunter Division, but are allowed to use bits that are included in the Dressage Division.
- 3. Page 69 add to Reinsmanship rule

M.6 Reinsmanship

To be judged: 40% on the performance of the driver and ability to change gaits quickly and smoothly while maintaining contact and demonstrating correct driving techniques while following the pattern or test, 40% on handling of reins and whip, control, posture, and overall appearance of driver; 20% on the condition of harness and vehicle and neatness of attire.

- 4. Page 23, under Attire, the wording should be Dress Boots instead of Hunt Boots
- 5. Heading for page 37 "Acceptable bits for Hunter Division"
- 6. There is also an updated scoring system for the Horsemanship, Equitation and Showmanship that is being worked on
- 7. Page 3 will need to be updated with to reflect the changes below for Amateurs.

Here is the Supplement Update for 2023 Amateur Declaration Document:

- 1. In the Amateur Declaration document delete the rule about commissioned horses: "f. Accepts remuneration AND acts as an agent in the sale of a horse or pony or accepts a horse or po..."
- 2. Working as a judge was taken off of the list of allowed activities for amateurs but was not added to the list of things that are not allowed. Change f to: Accepts remuneration for judging a horse show and or holds the credentials of a horse show judge for any organization.

Gale Rempel made a motion to accept all the recommended rule changes and updates, Samantha VanSickle seconded the motion. None opposed. Rules document and amateur document will be revised and posted.

Kate Walls requested that the board consider evaluation fees reduced from current USD to something more fair for Canadian members due to the exchange rate. It was discussed that it is more efficient and easier for our Canadian members to pay direct to the evaluation organizer in Ca

dollars then the organizer will be responsible to pay the GVHS. Proposed that evaluation in Canada for a horse age 3 and over be \$125ca and horse under age 3 be \$100ca. Gale Rempel made the motion to adopt these fees for Canadian evaluations and to pay direct to organizer, Samantha VanSickle seconded the motion. None opposed.

It was discussed that the actual birthdate should be used for the under/over age 3 evaluation rule.

Judges Committee – Gale Rempel stated that the committee would like to add two additional committee members from the membership. This committee will now be handling judge feedback issues.

OLD BUSINESS

Committee Members – the volunteers were reviewed based on their requested committees. Once determined, Barb Snyder will contact them and request signed committee code of ethics forms.

Resolution without meeting Feb 18th, 2023- A recommendation was put to the Board to increase the pay of the Registrar by 10% beginning Feb 2023. All Directors agreed with this increase based on growth in number of registrations, transfers, and memberships being processed since she started the position. Also due to large increase in show points program demand due to growth and changes to that program. No one opposed.

NEW BUSINESS

Executive Director job – Barb Snyder provided the Directors with details of the position. She will provide a job ad to be posted. It is agreed that candidates should be considered within the organization and from the equine industry. The position will be posted on the GVHS website, Vanner Banner, social media, and Wayne Hipsley will be asked to distribute among his contacts.

Expo Manager – The following will be added to the sponsored breed booth document to pay and reimburse breed booth managers.

Publications – Publications Coordinator job position was discussed regarding structure of the duties, pay and requirements.

The Vanner 2024 – ad prices for 2024 were discussed and recommended. Barb Snyder will create a spreadsheet showing the ad dollars sold per ad size for the 2023 issue and compare to the recommended 2024 ad prices.

Grievance— the grievance in process was discussed. The GVHS bylaws state a hearing must be requested within 30 days of any decision or action. The Directors agreed to accept the grievance committee recommendation to inform the person in question directly that they have a right to a hearing on the matter of the suspension or expulsion from the GVHS.

The rules committee will be provided with some examples of detail horse welfare policies and asked to develop a detailed policy for the GVHS.

Evaluation – Barb Snyder proposed that some type of motivation be considered in order to get evaluation entries in earlier in order to make decisions regarding the event and allowing evaluators to make travel plans earlier. It should be something that does not penalize so it does not discourage entries. Some type of bonus or prize for early entry was suggested. Hold for further discussion.

Show Awards for 2023 show season were discussed. No suggestions have been received for different types of awards. Decision will be made by next meeting.

Cloned Horses were brought up for discussion. In 2013 a court ordered the AQHA to register cloned horses. Update to this: In 2015 the AQHA won an appeal and they do not register cloned horses or their offspring. The GVHS has a rule in place that states Cloned Horses are not eligible for registration. It is proposed that language be added: Cloned Horses or their offspring will not be eligible for registration.

Amendment to the September 12, 2023 BOD Meeting Minutes:

"During the BOD Meeting on September 12, 2023, there was a discussion about the Congress Show in MO. The content of the discussion came from a Complaint from Samantha Crook regarding the way the Classes were placed during the show.

The Show used three judges, in which only two were considered for GVHS Points.

During the Halter portion of the Show, the class results from all three judges were combined (which is a GVHS violation of Rules). This caused the Grand Champion Mare (GG Kiss Me Kate, owned by Samantha Crook) to be eliminated from the opportunity to be presented to the Judges for the GVHS Supreme Halter title. The complaint that was received from Samantha Crook regarding the Supreme Champion class, and how her Mare was not able to move into the Class for consideration as the Supreme Halter Horse, was discussed but inadvertently left out of the minutes.

Combining scores is a violation of the GVHS rules, and this in turn was the reason for the Letter explaining the GVHS Rule violation, which was sent to the Show Manager, Duane Stutzman, of the Congress show in Mo. in Sept of 2023."

• Due to the grievance that was filed in regard to an incident at a GVHS sanctioned show where a horse was abused during a class. The Show Rules is be updated with detailed information on what is considered abuse both to horses and toward other participants and what the punitive action will be as a reference for show officials.

The Show Rules will be updated with a penalty chart for reference in the future to guide show managers, judges, and members on what is considered abusive treatment of horses during a GVHS sanctioned show and what the penalty will be implemented for any violation of the humane treatment of horses or other abusive behavior.

Penalties could be removal from class with loss of points up to the suspension from an entire show with loss of all points gained during said show. Additionally, the penalties chart will

include official actions for abuse against judges, show officials, or other competitors.

A discussion was also held regarding Costume Classes at GVHS sanctioned shows. At this time, Costume classes are not allowed specifically in the case of bareback and/or nonBridle costumes. It is felt that free-style classes are losing entrants due to not being able to use costumes.

It was suggested that if pictures of the costumes were submitted to officials prior to the class to be approved for safety. Gale suggested that the bareback/non-bridle rule come back to the board for approval. Committee agreed to revisit the costume issue for further consideration.

• Show Points were discussed. Committee members did research on changing show points and recommended keeping show points as they are currently.

Board appreciates the Committees effort in researching the show points issue for consideration.
